## 1.Context

At Northampton School for Girls (NSG) it is our intention that all of our students should continue with their learning post-16, within a context that may be education or training. Using the guidance process at KS4, the choices should be appropriate to students' aspirations and skills and may lead to apprenticeships, college courses or a continuation of their study in the Sixth Form.

All NSG students who wish to continue their education post-16 at the school will be able to do so, provided the right courses are available to meet their needs, and that they meet the entry requirements.

In addition to our own Year 11 students (referred to as 'Internals'), the school admits students, including boys, who are studying for GCSEs at other schools (referred to as 'Externals') to study level 3 qualifications (A levels and level 3 BTECs). The Admissions Number for external applicants is 50. If spaces remain on some courses, this number can be exceeded, provided that the additional students only follow courses where space is available. The academic admissions criteria for Internal and External students is the same (See point 2).

## 2. Entry requirements

We provide three pathways to Level 3 qualifications (see points 1.ii-1.iv below), to ensure students are able to access the curriculum and make good progress, leading to successful post-18 progression. There are general minimum entry requirements for all (See point 1.i). In addition, students' best 8 GCSE grades will be used to denote which pathway is available to them.
i. General entry requirements: students must achieve:

- Grade 4 in GCSE English (either Language or Literature)
- Grade 4 in GCSE Maths
- N.B: If a student does not have a grade 4 in English Language or Maths, they will be expected to retake the exam in Year 12

In all cases, the requirements outlined below are a minimum for general entry/pathway entry and subject-specific criteria are required in addition (See Appendix 2).
*Students without grade 4 in both English and Maths may be admitted onto Pathway 3 only, subject to them retaking GCSE English and Maths in Year 12.
ii. Pathway 1: open to students whose best 8 GCSE grades add up to 40+.

Three A Level programme of study (students who have achieved six or more subjects graded 8 or 9 may be eligible to study four A Levels). Pathway 1 students may wish to take a BTEC course.

iii. Students may take additional qualifications (e.g. the Extended Project Qualification) but all students must follow a minimum number of three subjects
iv. The school reserves the right to remove courses in the September if numbers are not viable; students who have been offered a place will be able to move to a different subject, but acceptance onto any course remains dependent on the student's GCSE performance and subject-specific criteria.

## 3.Oversubscription Criteria

## i. General oversubscription criteria

All External applicants meeting the minimum entry and subject specific academic requirements and completing a Sixth Form Application Form will be offered a place, except that if the number applying is more than the Admissions Number, when the following oversubscription criteria will be used to determine to whom places are offered:
a. Students with an Education, Health and Care Plan (EHCP) will be offered a place, where the school, after consultation with the Local Authority, has been named on the statement as the appropriate post-16 provision. He/she will still need to meet the minimum entry and subject specific academic requirements.
b. Children in public care (Looked After Children) or previously in public care (Previously Looked After Children). This includes those who are (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions at the time of making an application to the school. 'Previously Looked After Children' are defined for the purposes of the legislation as those who immediately after being in care became subject to an adoption, child arrangements, or special guardianship order. (Parents must supply a copy of the relevant order as evidence of their child's status.)
c. Children of staff. Children of staff directly employed by Northampton School for Girls will be allocated a place if either or both of the following conditions are met: a) where the
member of staff has been employed at the school for two or more years at the time at which the application for admission to the school is made, and/or b) the member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage.

Fair, or random, allocation of the remaining places is used to decide which students will be offered the remaining places after the above criteria have been applied. This will be done by allocating places in a statistically random order generated by computer. This process is approved by the Department for Education as a fair and objective method of allocating places when there are more applicants than there are places available and the number of places available is exceeded within any criterion.

## ii. Course oversubscription criteria

Students who wish to study a subject which attracts, on average, a class size of over 27 students, and where there is no capacity to put on a further group, will be asked to select a reserve choice. In addition, some subject combinations may not be possible due to timetabling constraints, and students will then be asked to choose between two subjects and identify another choice. The procedure for selecting students to follow a reserve choice course is as follows:
a. All students who have selected the option will be invited to take up their reserve choice if they have no strong preference.
b. Students who did not meet the application deadline of $3^{\text {rd }}$ February 2023.
c. Students who did not attend $6^{\text {th }}$ Form Induction (and the reason for this had not been authorised by NSG, will be required to take up their reserve choice).
d. Students who did not meet the declaration of results deadline (1pm on GCSE Results Day), and had not made prior arrangements with the school.
e. If, however, numbers still need to be reduced, then the following will be taken into consideration: ranking by GCSE grade in relevant subject (if applicable), ranking by Best 8 Score and any extenuating circumstances.

The final decision regarding students' places on courses lies with the school. A waiting list for each course will be held until $1^{\text {st }}$ October 2023 in line with our over-subscription criteria. Plans for Year 12 courses at NSG are provisional, dependent on group sizes and timetabling constraints. All rights to modify the provisional curriculum lie with the school.

## 4.Admission of children outside their normal age group

An Out of Cohort Admission Application is an application that is made for a place at Northampton School for Girls outside the normal age group for the student. Parents/carers wishing to make this request will have the opportunity to provide the school with evidence to demonstrate their reasoning,
and are strongly advised to do so. The school will make the decision on the basis of the circumstances of each case and in the best interests of the child concerned. This will include taking account of: the parent's views; information about the child's academic, social and emotional development; where relevant, their medical history and the views of a medical professional; whether they have previously been educated out of their normal age group; and whether they may naturally have fallen into a lower age group if it were not for being born prematurely; the views of the head teacher. When informing a parent of their decision, the school will provide the reasons for the decision.

## 5.Appeals

Any student refused a place in the Sixth Form has the right of appeal to an independent appeals panel. Details of how to appeal can be obtained from the school.

## 6.Admissions Timetable

i. Application deadline $-3^{\text {rd }}$ February 2023
ii. Conditional offers made - March 2023
iii. Publication of GCSE results - August 2023
iv. School agrees/declines the admission at enrolment - August 2023
v. Decision communicated to parent/student - August/September 2023
vi. Independent Appeal - September 2023

## 7.Late applicants/In-year Admissions

i. Late applications will be considered up to the end of September.
ii. Where an application is received on behalf of a student who has moved into the area during the academic year, it will be considered in accordance with the minimum entry requirements, oversubscription criteria and whether the student has a reasonable chance of completing the course in the time available.
iii. The right of appeal will also apply to late applications and in-year admissions.

## Appendix 1

## What is the Best 8 GCSE score?

The best 8 score is the total of the best 8 grades the student achieved in their GCSEs. Please see the examples below to explain how this works.

## Example A:

Best 8 score $=70$
This student would therefore be eligible for Pathway 1: A Levels (this student would also be eligible to be considered for four A Levels)
